The Provincetown Conservation Commission will hold a Public Hearing at 6:30 p.m. on **Tuesday, February 21, 2017** in the Judge Welsh Room, Town Hall, 260 Commercial Street, Provincetown, MA to consider the following requests:

### [CON-17-126](#) **543 Commercial St**

Request for Determination of Applicability by Elaine Quigley pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s.40) and Provincetown General Bylaws Chapter 12, Wetland Protection Bylaw to remove existing asphalt and concrete and install pavers and cobblestone edging. Work to take place within Land Subject to Coastal Storm Flowage and the 100-foot Buffer Zone to the Coastal Beach.

Request for Determination of Applicability by Dorothy K. Seavey pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s.40) and Provincetown General Bylaws Chapter 12, Wetland Protection Bylaw to plant 3 rows of grasses, forbs and shrubs in an area presently lacking vegetation. Work to take place within the Coastal Beach and Land Subject to Coastal Storm Flowage.

Notice of Intent by Christopher Wise pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s.40) and Provincetown General Bylaws Chapter 12, Wetland Protection Bylaw to dig trenches in roadways and campsites to bring electric, water and sewer connections to 183 campsites. Work to take place within NHESP Estimated and Priority Habitat, Bordering Land Subject to Flooding, and the 100 - foot Buffer Zone to Bordering Vegetated Wetland.

Request for Partial Certificate of Compliance by Greg Connors pursuant to the Massachusetts Wetlands Protection Act (M.G.L. c. 131, s.40) and Provincetown General Bylaws Chapter 12, Wetland Protection for construction of foundation pilings, deck and house. Work took place with the 100-foot Buffer Zone to the Coastal Beach and Land Subject to Coastal Storm Flowage.
