Wampanoag Memorial meeting: J. Krajovic went to the meeting in which the latest plan for memorial was presented. Several people at the meeting asked for review of the current design. The meeting seemed productive. The select board approved the Bas Relief documents and a plan to move ahead with that. The Wampanoag Memorial will undergo further review. Some have suggested locating it at First Landing Park. People definitely want a memorial, but the town still needs to determine where it will be best suited.

Funicular: Meeting Jan 14 to talk about funicular traffic plan. A traffic study hasn't been done yet.

Shank Painter: Dec 10 is the Shank painter meeting.

Memorial benches: Anika suggested that we consider a memorialization system with time limits. Perhaps memorialization lasts for 2 years or some other set time period? It would provide a flexibility that would allow for more people to be memorialized.
