The meeting was called to order at 4: p.m. with a quorum.

## **Public Statements**

Pam P. commented on the background and consideration of establishing a Local Housing Bank if the Town intends on creating a Housing In-Lieu Fee. The Housing Trust Fund is limited by Mass General Law to support "low income" housing units (60% AMI). The creation of a Local Housing Bank could be used to support the community's greater housing needs, including support for moderate, median or middle housing programs.

# **Employer-Assisted Housing Program**

Vicki Marchant, HAC, made a presentation on the benefits and requirements of the Employer Assisted Housing Program. HAC has received a \$250,000 grant from the State to administer the program. The program requires a matching grant from the employer of up to \$2500 for rental and up to \$5000 for purchase. Program eligible participants must make under 110% AMI. Program began in April 2008 and is modeled after the REACH Program in Chicago. The premise is to fill the affordability gap between salaries and housing costs. In order for the Town to participate for municipal employees, a source for the matching grant will need to be identified. Use of the Housing Trust Fund for the Town's match would be restricted to incomes below 60% AMI, pursuant to the Housing Trust Fund criteria.

Board members will look over the information and continue to the next meeting.

## **Local Preference Policy Update**

Proposed language is being reviewed by DHCD. The item should be continued to the next meeting to await DHCD comments.

The PCHC discussed bylaw changes and having a joint meeting with the Planning Board.
